## Resolution of the Christian County Republican Central Committee

Requesting Governor Parson to Call for a Special Session of the Missouri General Assembly

WHEREAS, the Christian County Republican Central Committee (CCRCC) is committed to the preservation and expansion of conservative principles that govern our great state of Missouri and the United States;

WHEREAS, the CCRCC believes that certain legislative matters of significance to our county, state, and nation require urgent attention and expedited legislative action;

WHEREAS, Missouri's citizens have displayed consistent support for the principles of limited government, fiscal responsibility, individual liberty, and free enterprise;

WHEREAS, there is an urgent need to address and promote these principles within the current legislative framework, to better serve the citizens of our great state;

WHEREAS, it is within the constitutional power of the Governor of Missouri to call for a special legislative session pursuant to Article IV, Section 9 of the Missouri Constitution;

NOW, THEREFORE, BE IT RESOLVED by the Christian County Republican Central Committee that:

We respectfully request Governor Parson call for a special session of the Missouri General Assembly at the earliest possible date to address the various separate and specific legislative matters below, deemed to be of critical importance to the citizens of Christian County and Missouri as a whole and which were not addressed properly during the Regular Session of the  $102^{nd}$  General Assembly:

- 1) Enact Initiative Petition (IP) Reform raising the threshold needed to amend our Missouri Constitution.
- 2) Allow gold and silver bullion to be used as legal tender in Missouri.
- 3) Prohibit land ownership by foreign individuals, companies, and entities.
- 4) Enact real estate and personal property tax limits/freezes for all Missouri real estate and personal property owners.
- 5) Any product manufactured or grown that is designed to be ingested or otherwise used in the human body, which used mRNA in its production or growth, shall be conspicuously labeled; and no company or school may require anyone to get such vaccines using mRNA technology.

We implore all members of the Missouri General Assembly to act in the best interest of their constituents, keeping in mind the principles that we believe are essential to the well-being and prosperity of our state.

We further request Governor Parson to VETO HB447 that will allow non-profits (including Planned Parenthood) to promote their agendas upon our children in our public schools.
