



Freedom Principle MO Announces Ballot Initiative to Protect Missourian's Right to Informed Consent

(Monday, August 14, 2023 – St. Louis, MO)

The Freedom Principle MO is announcing it has submitted a ballot initiative to the Missouri Secretary of State to protect Missourian's Right to Informed Consent. "The Freedom Principle MO has been working with legislators for more than two years trying to get them to ban vaccine and mask mandates, but we continue to be thwarted by the medical industrial cartel, the Missouri Chamber of Commerce, and the national and state radical teachers' unions," said Byron Keelin, President of the Freedom Principle MO. "The Freedom Principle MO through the Freedom Principle MO – Missouri First PAC will be soon starting to collect signatures to give Missourians the ability to reclaim our individual medical freed and declare our right to informed consent."

The ballot initiative will amend Article I of the Missouri Constitution and read as follows:

"The Right to Informed Consent." - That individuals have fundamental rights to informed consent and to refuse any medical technologies, procedures, or treatment, including, but not limited to injections, vaccines, or prophylactics. No law, rule, order, ordinance, or regulation shall require, mandate, or coerce any person to receive or use a medical procedure, treatment, vaccine, prophylactic, pharmaceutical, or medical device nor discriminate against the individual who exercises this right. Informed consent includes the right to be informed about exposure to mRNA and/or gene-altering therapies and medical technologies or treatment.

The proposed initiative must go through a review by the Missouri Secretary of State, Attorney General, and State Auditor. If the proposed ballot language is approved, the Freedom Principle MO will be working to collect the required signatures in six of the eight congressional districts by May 5, 2024, for signature verification. If the ballot initiative meets the required signature threshold, the proposed Right to Informed Consent amendment will appear on the November 2024 general election ballot.

“The response to the COVID Pandemic is one of the most appalling crimes against humanity,” said Keelin. “Missourians and Americans were lied to by big pharma, Dr. Fauci, and other government agencies, big tech, and the media. The Freedom Principle MO will be working with other grassroots organizations and county Republican Central Committees across the state to get the necessary signatures. “This will be a challenge given the short amount of time,” said Keelin. “The grassroots organizations and county republican leaders are frustrated by our governor and legislature’s lack of urgency to protect our individual medical freedom and therefore we are taking our efforts to Missourians and giving them the right to decide.”

The Freedom Principle MO will be having an official kickoff for the Informed Consent Amendment as soon as the Secretary of State gives the approval to begin collecting signatures.
