

Freedom Principle MO Begins Collecting Signatures for Ballot Initiative to Protect Missourian's Right to Informed Consent

(Monday, November 27, 2023 – St. Louis, MO)

The Freedom Principle MO – Missouri First PAC is excited to announce it has begun collecting signatures for its proposed initiative petition to protect Missourians' Right to Informed Consent. "We recently received the final ballot language from the Secretary of State and are now ramping up with our grassroots volunteers across the state and to collect signatures to get our initiative on the 2024 ballot," said Byron Keelin, President of the Freedom Principle MO.

The ballot initiative will amend Article I of the Missouri Constitution and read as follows: <u>That individuals have a right to refuse interventions upon his or her person and that freedom from</u> <u>governmental interference with that right is a fundamental right. And that pursuant to that right, the</u> <u>state and any political subdivision of the state, including schools and institutions of higher education are</u> <u>obligated to ensure informed consent when promoting any medical intervention and shall be prohibited</u> <u>from passing or implementing any law, order, ordinance, regulation, or public policy that mandates,</u> <u>coerces, or infringes upon the individual right to refuse any medical treatment, technology, testing, facial</u> <u>coverings, medical devices and/or procedures, including but not limited to injections and vaccines.</u>

Informed consent includes the right to be informed about exposure to mRNA and/or gene-altering therapies and medical technologies or treatments.

Equality of rights under the law shall not be denied or abridged to any person in this state because of the exercise of the rights ensured by this section. Nothing in this section shall be construed to secure or protect a right to abortion.

The Freedom Principle MO – Missouri First PAC is working with grassroots organizations around the state to collect the 171,600 signatures needed to get the initiative on the 2024 ballot. "The Freedom Principle MO is asking for volunteers to help collect signatures in all congressional districts. This is going to be a true grassroots operation," said Keelin. "We must reach a certain number of signatures in six of the eight congressional districts by May 5, 2024."

The Freedom Principle MO has been working with legislators for more than two years to get them to ban vaccine and mask mandates. "The grassroots organizations and county republican leaders are frustrated by our governor and legislature's lack of urgency to protect our individual medical freedom. Therefore, we are taking our efforts to Missourians and giving them the right to decide," said Keelin. "We are using the initiative petition process because we have been blocked by the medical-industrial complex, the Missouri Chamber of Commerce, and even Republican leadership."
