Dear Governor Parson, Director of Health and Senior Services Paula Nickelson, and Attorney General Bailey:

The Freedom Principle MO sent you a letter in February asking you to halt all COVID-19 vaccinations and boosters until a fully independent, scientific investigation of the COVID-19 vaccines and boosters can be conducted to evaluate their efficacy in treating and preventing the transmission of the COVID-19 virus.

To this date, we have not received a response from your offices regarding this request. During these 10 months, we have since learned Pfizer hid nearly 80% of COVID-19 vaccine trial deaths from regulators, Pfizer may have misled consumers by advertising that the vaccines contained mRNA, but instead contained lab-created hybrids known as modRNA. Now, the Florida Surgeon General, Dr. Joseph A. Ladapo, is raising concerns about the potential for DNA integration into the human genome.

As the CDC is again calling for mask and vaccine mandates Governor Parson, please, as a matter of constitutional integrity, issue the following Executive Orders:

- Prohibiting any government political subdivision of the state, including schools and institutions of higher education, from issuing any type of mask or vaccine mandate.
- Prohibiting any employer including healthcare, or education facilities, from requiring the COVID-19 vaccination as a condition of employment, promotion, or attendance until the legislature can address this issue legislatively.

Director Nickelson, we are demanding you act on behalf of public safety and protect Missourians by calling for an immediate halt to all COVID-19 vaccinations and boosters.

Attorney General Bailey, we are asking you to launch an immediate investigation against Pfizer and other makers of COVID-19 vaccinations for potential consumer fraud issues for allegedly withholding test results data and potentially misleading the public by misrepresenting the ingredients contained in the mRNA vaccines.

We are calling for this immediate action based on the following evidence:

- According to a new forensic analysis in the International Journal of Vaccine Theory, Practice, and Research, Pfizer failed to disclose evidence of more than a 3.7-fold increase in the number of cardiac deaths among vaccine recipients compared to those who received a placebo.


- According to a report published by Tom Renz, Pfizer, the Food and Drug Administration (FDA), Centers for Disease Control and Prevention (CDC), mislead the public about the ingredients contained in the COVID-19 vaccines. Mr. Renz states the Pfizer vaccine is advertised as an mRNA vaccine but uses lab-created hybrids known as modRNA.
- In a letter sent by Dr. Joseph Ladapo to FDA Commissioner Dr. Robert M. Califf and CDC Director Mandy Cohen, Dr. Ladapo “raised alarms about potential nucleic acid contaminants in the Pfizer and Moderna COVID-19 mRNA vaccines, particularly those in combination with lipid nanoparticles and the identified Simian Virus 40 (SV40) promoter/enhancer DNA.” According to Dr. Ladapo’s letter, he states, “Lipid nanoparticles are an efficient vehicle for delivery of the mRNA in the COVID-19 vaccines into human cells, and may therefore be an equally efficient vehicle for delivering contaminant DNA into human cells. The presence of SV40 promoter/enhancer DNA may also pose a unique and heightened risk of DNA integration into host cells.”
- A study released in 2022, published by the Journal of Clinical Medicine (MDPI), found “that the SARS-CoV-2 RNA within the Pfizer vaccine can modify DNA within the human genome.”

The more the actual scientific data is released, the more it disproves the narrative of “safe and effective.” Given the additional medical information and scientific data now emerging regarding the harmful effects of the mRNA vaccine and treatments, Missouri must take bold action by halting the distribution and promotion of COVID-19 shots and issuing the Executive Order protecting Missourian’s Constitutional rights.

Medical fraud has been perpetrated on Missouri citizens. The Missouri Governor, its public health officials, and chief law enforcement agency should not be promoting any COVID shots or boosters until these treatments can be proven to be safe and full transparency has been given to the public.
