

Freedom Principle MO Releases 2024 Legislative Priorities – Focus for 2024 is Passing Concurrent Majority Ratification, Police Control, Education Reform, and Medical Freedom

The Freedom Principle MO released its Legislative Priorities for the 2024 legislative session. "These priorities were voted on by our members and are the top issues we will be discussing with Missouri lawmakers in 2024," said Byron Keelin, President of the Freedom Principle MO.

The Freedom Principle MO's legislative priorities address these key issues:

- Protect our state constitution by passing Concurrent Majority Ratification using state house districts
- Ban all electronic voting and tabulation machines
- Support an initiative petition to ban rank choice and approval style voting
- Support the return of control of the St. Louis City Metropolitan Police Department to the State Board of Commissions
- Support passing a proposed Constitutional Amendment or legislation protecting Missourian's right to informed consent
- Support passing legislation that would require the labeling of all products and/or food containing mRNA and/or gene-altering therapies
- Support legislation eliminating personal property taxes
- Support legislation to eliminate the Department of Elementary and Secondary Education (DESE) and allow parents to choose the best education for their children

"We were so dissatisfied with the House and Senate leadership last session," said Keelin. "Hopefully with this being an election year, Speaker Plocher and Senate President Rowden will do a better job of bringing key pieces of legislation to the floor to allow them to be voted on by our legislature."

"Our members are committed to working with legislators on our key legislative priorities this session," said Keelin. "It's time for our legislature to put its supermajority to work and pass legislation that puts Missourians first."
