AN ACT

To repeal sections 115.013, 115.045, 115.051, 115.081, 115.085, 115.105, 115.123, 115.135, 115.151, 115.155, 115.157, 115.160, 115.163, 115.165, 115.205, 115.225, 115.237, 115.257, 115.275, 115.277, 115.279, 115.283, 115.285, 115.287, 115.291, 115.302, 115.349, 115.351, 115.417, 115.427, 115.435, 115.447, 115.652, 115.755, 115.758, 115.761, 115.765, 115.767, 115.770, 115.773, 115.776, 115.785, 115.902, 115.904, and 115.960, RSMo, and to enact in lieu thereof forty-six new sections relating to elections, with penalty provisions.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Sections 115.013, 115.045, 115.051, 115.081, 115.085, 115.105, 115.123,
115.135, 115.151, 115.155, 115.157, 115.160, 115.163, 115.165, 115.205, 115.225, 115.237,
115.257, 115.275, 115.277, 115.279, 115.283, 115.285, 115.287, 115.291, 115.302, 115.349,
115.351, 115.417, 115.427, 115.435, 115.447, 115.652, 115.755, 115.758, 115.761, 115.765,
115.767, 115.770, 115.773, 115.776, 115.785, 115.902, 115.904, and 115.960, RSMo, are
repealed and forty-six new sections enacted in lieu thereof, to be known as sections 28.960,
115.004, 115.013, 115.022, 115.045, 115.051, 115.081, 115.085, 115.105, 115.123, 115.135,
115.151, 115.155, 115.157, 115.160, 115.163, 115.165, 115.168, 115.205, 115.225, 115.237,
115.257, 115.275, 115.277, 115.279, 115.283, 115.285, 115.286, 115.287, 115.291, 115.302,
115.349, 115.351, 115.417, 115.427, 115.435, 115.447, 115.628, 115.652, 115.776, 115.902,
115.904, 115.960, 1, 2, and 3, to read as follows:

EXPLANATION — Matter enclosed in bold-faced brackets [thus] in the above bill is not enacted and is intended to be omitted from the law. Matter in **bold-face** type in the above bill is proposed language.

28.960. 1. The secretary of state shall have the authority to, at his or her
2 discretion, audit the list of registered voters for any local election authority to ensure
3 accuracy.

4 2. Any audit conducted by the secretary of state shall, at least quarterly, 5 determine whether the local election authority has performed the following voter 6 registration list maintenance activities, as required by law:

7

(1) Sending verification notices in accordance with section 115.155; and

8 (2) Registering voters and removing names from the voter registration system in 9 accordance with section 115.158.

3. After completing the audit, the secretary of state shall notify the local election authority in writing of any maintenance updates that are required and shall advise the local election authority they have ninety days to make required updates. If, after ninety days, the secretary of state determines that the local election authority has not performed the required maintenance of voter registration lists as required by law, the secretary of state's office may withhold transaction funds associated with maintenance of the voter registration lists from the local election authority.

115.004. The sections of this chapter and all related rules and regulations shall 2 not be amended or modified in any manner in the twenty-six weeks preceding any 3 presidential election.

115.013. As used in this chapter, unless the context clearly implies otherwise, the 2 following terms mean:

3 (1) "Air-gap" or "air-gapped", a security measure in which equipment is 4 physically and technically isolated from any network and is not directly connected to the 5 internet nor is it connected to any other system that is connected to the internet. Data 6 can only be passed to an air-gapped device physically via a USB or other removable 7 media;

8 (2) "Automatic tabulating equipment", the apparatus necessary to examine and 9 automatically count votes, and the data processing machines which are used for counting 10 votes and tabulating results **and which are air-gapped and not physically able to be** 11 **connected to a network**;

12 [(2)] (3) "Ballot", the [ballot card,] paper ballot, or ballot designed for use with an 13 electronic voting system on which each voter may cast all votes to which he or she is entitled 14 at an election;

15 [(3) "Ballot card", a ballot which is voted by making a mark which can be tabulated
 16 by automatic tabulating equipment;]

17 (4) "Ballot label", the card, paper, booklet, page, or other material containing the 18 names of all offices and candidates and statements of all questions to be voted on;

(5) "Counting location", a location selected by the election authority for the automaticprocessing or counting, or both, of ballots;

(6) "County", any county in this state or any city not within a county;

(7) "Disqualified", a determination made by a court of competent jurisdiction, the
Missouri ethics commission, an election authority or any other body authorized by law to
make such a determination that a candidate is ineligible to hold office or not entitled to be
voted on for office;

26 (8) "District", an area within the state or within a political subdivision of the state 27 from which a person is elected to represent the area on a policy-making body with 28 representatives of other areas in the state or political subdivision;

(9) "Electronic voting machine", any part of an **air-gapped** electronic voting system
on which a voter is able to cast a ballot under this chapter;

(10) "Electronic voting system", a system of casting votes by use of marking devices,
and counting votes by use of automatic air-gapped tabulating or air-gapped data processing
equipment, including computerized voting systems that mark or tabulate ballots;

(11) "Established political party" for the state, a political party which, at either of the last two general elections, polled for its candidate for any statewide office more than two percent of the entire vote cast for the office. "Established political party" for any district or political subdivision shall mean a political party which polled more than two percent of the entire vote cast at either of the last two elections in which the district or political subdivision voted as a unit for the election of officers or representatives to serve its area;

40 (12) "Federal office", the office of presidential elector, United States senator, or 41 representative in Congress;

42 (13) "Independent", a candidate who is not a candidate of any political party and who 43 is running for an office for which political party candidates may run;

44 (14) "Major political party", the political party whose candidates received the highest45 or second highest number of votes at the last general election;

46 (15) "Marking device", any [approved] device approved by the secretary of state
47 under section 115.225 which will enable the votes to be counted by automatic tabulating
48 equipment;

49

(16) "Municipal" or "municipality", a city, village, or incorporated town of this state;

50 (17) "New party", any political group which has filed a valid petition and is entitled to 51 place its list of candidates on the ballot at the next general or special election;

52 (18) "Nonpartisan", a candidate who is not a candidate of any political party and who 53 is running for an office for which party candidates may not run;

54 (19) "Political party", any established political party and any new party;

55 (20) "Political subdivision", a county, city, town, village, or township of a township 56 organization county;

57 (21) "Polling place", the voting place designated for all voters residing in one or more 58 precincts for any election;

59 (22) "Precincts", the geographical areas into which the election authority divides its 60 jurisdiction for the purpose of conducting elections;

61 (23) "Public office", any office established by constitution, statute or charter and any 62 employment under the United States, the state of Missouri, or any political subdivision or 63 special district thereof, but does not include any office in the Missouri state defense force or 64 the National Guard or the office of notary public or city attorney in cities of the third 65 classification or cities of the fourth classification;

66

(24) "Question", any measure on the ballot which can be voted "YES" or "NO";

67 (25) "Relative within the second degree by consanguinity or affinity", a spouse,
68 parent, child, grandparent, brother, sister, grandchild, mother-in-law, father-in-law, daughter69 in-law, or son-in-law;

(26) "Special district", any school district, water district, fire protection district,
hospital district, health center, nursing district, or other districts with taxing authority, or other
district formed pursuant to the laws of Missouri to provide limited, specific services;

(27) "Special election", elections called by any school district, water district, fire
 protection district, or other district formed pursuant to the laws of Missouri to provide limited,
 specific services; and

76 (28) "Voting district", the one or more precincts within which all voters vote at a 77 single polling place for any election.

115.022. 1. Except as provided in subsection 5 of this section, neither the state of

2 Missouri nor any political subdivision thereof that conducts elections shall receive or

3 expend private moneys, excluding in-kind donations, for preparing, administering, or

4 conducting an election, including registering voters.

5 2. Notwithstanding subsection 1 of this section to the contrary, in-kind donations 6 shall not be received from any candidate, candidate committee, campaign committee, or 7 continuing committee, as such terms are defined in chapter 130.

8

3. For purposes of this section, "in-kind donations" shall only include:

9 (1) Personal protective equipment;

10 (2) Water;

11 (3) Locations at which an election may be conducted; and

12 (4) Food for an election authority, staff of an election authority, election judges,

13 watchers, and challengers.

4. The secretary of state is authorized to withhold funds from an election authority in violation of this section unless such funding is a federal mandate or part of a federal and state agreement.

17 5. In any even-numbered year in which the amount of state funds appropriated to proportionally compensate counties pursuant to sections 115.063 and 115.065 is less 18 19 than the amount of such funds that were appropriated in the previous even-numbered 20 year, private moneys may be received by the secretary of state to disburse to counties 21 based on the amount of registered voters in each county. The amount of private moneys 22 that may be received by the secretary of state shall not exceed the difference between the amount of state funds appropriated in the previous even-numbered year and the 23 24 amount appropriated in the pending even-numbered year, plus ten percent of the total amount that was appropriated in the previous even-numbered year. 25

115.045. Each election authority shall have the authority to employ such attorneys and other employees as may be necessary to promptly and correctly perform the duties of the 2 election authority. Where an electronic voting system or voting machines are used, the 3 4 election authority shall designate competent employees to have custody of and supervise maintenance of the voting equipment. Board of election commissioners' employees shall be 5 6 subject to the same restrictions and subscribe the same oath as members of the board of election commissioners, except that no employee of a board of election commissioners shall 7 be required to post bond or reside and be a registered voter within the jurisdiction of the 8 election authority unless directed to do so by the board. Employee oaths and any bonds shall 9 10 be filed and preserved in the office of the board.

115.051. 1. In each county which does not have a board of election commissioners, the county clerk shall have the right to employ such deputies and assistants as are necessary to 2 promptly and correctly register voters and conduct elections. Where an electronic voting 3 system or voting machines are used, the county clerk shall designate competent employees to 4 have custody of and supervise maintenance of the voting equipment. Each deputy shall be 5 6 subject to the same restrictions and subscribe the same oath as the county clerk, except that no employee shall be required to post bond or reside and be a registered voter within the 7 jurisdiction of the election authority unless directed to do so by the clerk. Employee oaths 8 and any bonds shall be filed and preserved in the office of the county clerk. 9

10 2. Within the total amount for deputies and assistants approved by the county 11 commission, the salary of each deputy and assistant shall be set by the county clerk.

115.081. 1. Each election authority shall appoint election judges for each polling2 place within its jurisdiction in accordance with the provisions of this section.

2. In all primary and general elections, the election authority shall appoint at least two judges from each major political party to serve at each polling place. **The committee of each**

major political party within the jurisdiction of an election authority is authorized to 5 provide the election authority with a list of election judge candidates who meet the 6 7 requirements under section 115.085. The candidates shall not be required to reside within the jurisdiction of the election authority, as authorized under section 115.085. If 8 9 a committee of a major political party within the jurisdiction of an election authority fails to provide the prescribed number of qualified names to fill all election judge 10 11 positions before the date established by the election authority, the election authority may 12 select judges to fill the positions as provided by law. If the election authority determines that a name submitted by a committee of a major political party is not qualified to serve 13 as an election judge, the election authority shall allow the party to submit another name 14 before filling the position as provided by law. No major political party shall have a 15 16 majority of the judges at any polling place. No established party shall have a greater number of judges at any polling place than any major political party. 17

3. In any election that is not a primary or general election, the election authority shall appoint at least one judge from each major political party to serve at each polling place. No major political party shall have a majority of the judges at any polling place. No established party shall have a greater number of judges at any polling place than any major political party.

4. The election authority shall designate two of the judges appointed for each polling place, one from each major political party, as supervisory judges. Supervisory judges shall be responsible for the return of election supplies from the polling place to the election authority and shall have any additional duties prescribed by the election authority.

26 5. Election judges may be employed to serve for the first half or last half of any 27 election day. Such judges shall be paid one-half the regular rate of pay. If part-time judges 28 are employed, the election authority shall employ such judges and shall see that a sufficient number for each period are present at all times so as to have the proper total number of judges 29 present at each polling place throughout each election day. The election authority shall 30 require that at each polling place at least one election judge from each political party serve a 31 32 full day and that at all times during the day there be an equal number of election judges from 33 each political party.

6. An election authority may appoint additional election judges representing other established political parties and additional election judges who do not claim a political affiliation. Any question which requires a decision by the majority of judges shall only be made by the judges from the major political parties.

115.085. No person shall be appointed to serve as an election judge who is not a
registered voter in this state[; provided that, before any election authority may appoint judges
who are registered voters of another election authority's jurisdiction, the election authority

4 shall obtain the written consent of the election authority for the jurisdiction where the

prospective judges are registered to vote]. Each election judge shall be a person of good 5 repute and character who can speak, read, and write the English language. No person shall 6 7 serve as an election judge at any polling place in which his or her name or the name of a relative within the second degree, by consanguinity or affinity, appears on the ballot. 8 9 However, no relative of any unopposed candidate shall be disqualified from serving as an election judge in any election jurisdiction of the state. No election judge shall, during his or 10 11 her term of office, hold any other elective public office, other than as a member of a political 12 party committee or township office, except any person who is elected to a board or commission of a political subdivision or special district may serve as an election judge except 13 at a polling place where such political subdivision or special district has an issue or candidate 14 on the ballot. In any county having a population of less than two hundred fifty thousand 15 inhabitants, any candidate for the county committee of a political party who is not a candidate 16 for any other office and who is unopposed for election as a member of the committee shall not 17 be disqualified from serving as an election judge. 18

115.105. 1. The chair of the county committee of each political party named on the 2 ballot shall have the right to designate a challenger for each polling place, who may be present until all ballots are cast on the day of election, and a challenger for each location at 3 4 which absentee ballots are counted, who may be present while the ballots are being prepared for counting and counted. No later than four business days before the election, the chair of 5 6 each county committee of each political party named on the ballot shall provide signed official designation forms with the names of the designated challengers and substitutes to the 7 8 local election authority for confirmation of eligibility to serve as a challenger. The local election authority, after verifying the eligibility of each designated and substitute challenger, 9 shall sign off on the official designation forms, unless the challenger is found not to have the 10 qualifications established by subsection 5 of this section. If the election authority determines 11 that a challenger does not meet the qualifications of subsection 5 of this section, the 12 designating party chair may designate a replacement challenger and provide the local election 13 14 authority with the name of the replacement challenger before 5:00 p.m. of the Monday 15 preceding the election. The designating chair may substitute challengers at his or her 16 discretion during such hours.

17 2. Challenges may only be made when the challenger believes the election laws of 18 this state have been or will be violated, and each challenger shall report any such belief to the 19 election judges, or to the election authority if not satisfied with the decision of the election 20 judges.

3. Prior to the close of the polls, challengers may list and give out the names of those who have voted. The listing and giving out of names of those who have voted by a challenger shall not be considered giving information tending to show the state of the count. 4. [In a presidential primary election, challengers may collect information about the
 party ballot selected by the voter and may disclose party affiliation information after the polls
 close.

5.] All persons selected as challengers shall have the same qualifications required by section 115.085 for election judges, except that such challenger shall be a registered voter in the jurisdiction of the election authority for which the challenger is designated as a challenger.

30 [6.] 5. Any challenge by a challenger to a voter's identification for validity shall be 31 made only to the election judges or other election authority. If the poll challenger is not 32 satisfied with the decision of the election judges, then he or she may report his or her belief 33 that the election laws of this state have been or will be violated to the election authority as 34 allowed under this section.

115.123. 1. All public elections shall be held on Tuesday. Except as provided in
subsections 2 and 3 of this section, and section 247.180, all public elections shall be held on
the general election day, the primary election day, the general municipal election day, the first
Tuesday after the first Monday in November, or on another day expressly provided by city or
county charter, and in nonprimary years on the first Tuesday after the first Monday in August.
Bond elections may be held on the first Tuesday after the first Monday in February but no
other issue shall be included on the ballot for such election.

8 2. [Notwithstanding the provisions of subsection 1 of this section, an election for a
 9 presidential primary held pursuant to sections 115.755 to 115.785 shall be held on the second
 10 Tuesday after the first Monday in March of each presidential election year.

11 3.] The following elections shall be exempt from the provisions of subsection 1 of 12 this section:

13

(1) Bond elections necessitated by fire, vandalism or natural disaster;

14 (2) Elections for which ownership of real property is required by law for voting;

15

(3) Special elections to fill vacancies and to decide tie votes or election contests; and

16 (4) Tax elections necessitated by a financial hardship due to a five percent or greater 17 decline in per-pupil state revenue to a school district from the previous year.

[4.] 3. Nothing in this section prohibits a charter city or county from having its
primary election in March if the charter provided for a March primary before August 28,
1999.

[5.] 4. Nothing in this section shall prohibit elections held pursuant to section 65.600,
but no other issues shall be on the March ballot except pursuant to this chapter.

115.135. 1. Any person who is qualified to vote, or who shall become qualified to 2 vote on or before the day of election, shall be entitled to register in the jurisdiction within

3 which he or she resides. In order to vote in any election for which registration is required, a

4 person must be registered to vote in the [jurisdiction of his or her residence] state of Missouri

5 no later than 5:00 p.m., or the normal closing time of any public building where the 6 registration is being held if such time is later than 5:00 p.m., on the fourth Wednesday prior to 7 the election, unless the voter is an interstate former resident, [an intrastate new resident,] a 8 new resident, or a covered voter, as defined in section 115.275. [Except as provided in 9 subsection 4 of this section, in no case shall registration for an election extend beyond 10:00 10 p.m. on the fourth Wednesday prior to the election.] Any person registering after such date 11 shall be eligible to vote in subsequent elections.

A person applying to register with an election authority or a deputy registration
 official shall identify himself or herself by presenting a copy of a birth certificate, a Native
 American tribal document, other proof of United States citizenship, a valid Missouri drivers
 license or other form of personal identification at the time of registration.

3. Except as provided in federal law or federal elections and in section 115.277, no
person shall be entitled to vote if the person has not registered to vote in the jurisdiction of his
or her residence [prior to the deadline to register to vote].

4. A covered voter as defined in section 115.275 who has been discharged from military service, has returned from a military deployment or activation, or has separated from employment outside the territorial limits of the United States after the deadline to register to vote, and who is otherwise qualified to register to vote, may register to vote in an election in person before the election authority until 5:00 p.m. on the Friday before such election. Such persons shall produce sufficient documentation showing evidence of qualifying for late registration pursuant to this section.

115.151. 1. Each qualified applicant who appears before the election authority shall
be deemed registered as of the time the applicant's completed, signed and sworn registration
application is witnessed by the election authority or deputy registration official.

2. Each applicant who registers by mail shall be deemed to be registered as of the date the application is postmarked, if such application is accepted and not rejected by the election authority and the verification notice required pursuant to section 115.155 is not returned as undeliverable by the postal service.

8 3. Each applicant who registers at a voter registration agency or the division of motor vehicle and drivers licensing of the department of revenue shall be deemed to be registered as 9 of the date the application is signed by the applicant, if such application is accepted and not 10 rejected by the election authority and the verification notice required pursuant to section 11 115.155 is not returned as undeliverable by the postal service. Voter registration agencies 12 [and the division of motor vehicle and drivers licensing of the department of revenue] shall 13 14 transmit voter registration application forms to the appropriate election authority not later than five business days after the form is completed by the applicant. The division of motor 15 vehicle and drivers licensing of the department of revenue shall transmit voter 16

17 registration application forms to the appropriate election authority not later than three

18 business days after the form is completed by the applicant.

115.155. 1. The election authority shall provide for the registration of each voter.2 Each application shall be in substantially the following form:

The options for political party affiliation required by the application 74 described in subsection 1 of this section shall include all established political parties and 75 an option to be unaffiliated. If an applicant does not designate an affiliation, the election 76 authority shall mark the applicant's form as unaffiliated.

3. After supplying all information necessary for the registration records, each applicant who appears in person before the election authority shall swear or affirm the statements on the registration application by signing his or her full name, witnessed by the signature of the election authority or such authority's deputy registration official. Each applicant who applies to register by mail pursuant to section 115.159, or pursuant to section 115.160 or 115.162, shall attest to the statements on the application by his or her signature.

83 [3.] 4. Upon receipt by mail of a completed and signed voter registration application, 84 a voter registration application forwarded by the division of motor vehicle and drivers 85 licensing of the department of revenue pursuant to section 115.160, or a voter registration 86 agency pursuant to section 115.162, the election authority shall, if satisfied that the applicant 87 is entitled to register, transfer all data necessary for the registration records from the 88 application to its registration system. Within seven business days after receiving the 89 application, the election authority shall send the applicant a verification notice. If such notice is returned as undeliverable by the postal service within the time established by the election 90 91 authority, the election authority shall not place the applicant's name on the voter registration 92 file.

93 [4.] **5**. If, upon receipt by mail of a voter registration application or a voter 94 registration application forwarded pursuant to section 115.160 or 115.162, the election 95 authority determines that the applicant is not entitled to register, such authority shall, within 96 seven business days after receiving the application, so notify the applicant by mail and state 97 the reason such authority has determined the applicant is not qualified. The applicant may 98 file a complaint with the elections division of the secretary of state's office under and pursuant 99 to section 115.219. If an applicant for voter registration fails to answer the question on the application concerning United States citizenship, the election authority shall notify the 100 101 applicant of the failure and provide the applicant with an opportunity to complete the form in 102 a timely manner to allow for the completion of the registration form before the next election.

103 [5.] 6. The secretary of state shall prescribe specifications for voter registration 104 documents so that they are uniform throughout the state of Missouri and comply with the 105 National Voter Registration Act of 1993, including the reporting requirements, and so that 106 registrations, name changes and transfers of registrations within the state may take place as 107 allowed by law.

108 [6.] 7. All voter registration applications shall be preserved in the office of the 109 election authority.

115.157. 1. The election authority may place all information on any registration cards 2 in computerized form in accordance with section 115.158. No election authority or secretary 3 of state shall furnish to any member of the public electronic media or printout showing any 4 registration information, except as provided in this section. Except as provided in subsection 5 2 of this section, the election authority or secretary of state shall make available electronic 6 media or printouts showing **only** unique voter identification numbers, voters' names, [dates] **year** of birth, addresses, townships or wards, and precincts. Electronic data shall be 7 maintained in at least the following separate fields: 8 9

- (1) Voter identification number;
- (2) First name: 10
- 11 (3) Middle initial;
- 12 (4) Last name;
- 13 (5) Suffix;
- 14 (6) Street number;
- 15 (7) Street direction;

29 2. All election authorities shall enter voter history in their computerized registration systems and shall, not more than [six] three months after the election, forward such data to 30 31 the Missouri voter registration system established in section 115.158. In addition, election authorities shall forward registration and other data in a manner prescribed by the secretary of 32 33 state to comply with the Help America Vote Act of 2002.

34 3. Except as provided in subsection 6 of this section, the election authority shall furnish, for a fee, electronic media or a printout showing **only** the names, [dates] year of birth 35

36 [and], addresses, and political party affiliations of voters, or any part thereof, within the 37 jurisdiction of the election authority who voted in any specific election, including primary 38 elections, by township, ward or precinct, provided that nothing in this chapter shall require 39 such voter information to be released to the public over the internet and shall not be used for 40 commercial purposes.

41 4. Except as provided in subsection 6 of this section, upon a request by a candidate, a 42 duly authorized representative of a campaign committee, or a political party committee, the 43 secretary of state shall furnish, for a fee determined by the secretary of state and in 44 compliance with section 610.026, media in an electronic format or, if so requested, in a printed format, showing the names, addresses, and voter identification numbers of voters 45 46 within the jurisdiction of a specific election authority who applied for an absentee ballot under section 115.279 for any specific election involving a ballot measure or an office for 47 which the declaration of candidacy is required to be filed with the secretary of state pursuant 48 to section 115.353, including primary elections, by township, ward, or precinct. Nothing in 49 this section shall require such voter information to be released to the public over the internet. 50 51 For purposes of this section, the terms "candidate", "campaign committee", and "political 52 party committee" shall have the same meaning given to such terms in section 130.011.

53 5. The amount of fees charged for information provided in this section shall be established pursuant to chapter 610. All revenues collected by the secretary of state pursuant 54 55 to this section shall be deposited in the state treasury and credited to the secretary of state's 56 technology trust fund account established pursuant to section 28.160. In even-numbered 57 years, each election authority shall, upon request, supply the voter registration list for its jurisdiction to all candidates and party committees for a charge established pursuant to 58 chapter 610. Except as provided in subsection 6 of this section, all election authorities shall 59 60 make the information described in this section available pursuant to chapter 610. Any 61 election authority who fails to comply with the requirements of this section shall be subject to 62 the provisions of chapter 610.

63 6. Any person working as an undercover officer of a local, state or federal law 64 enforcement agency, persons in witness protection programs, and victims of domestic 65 violence and abuse who have received orders of protection pursuant to chapter 455 shall be entitled to apply to the circuit court having jurisdiction in his or her county of residence to 66 have the residential address on his or her voter registration records closed to the public if the 67 68 release of such information could endanger the safety of the person. Any person working as 69 an undercover agent or in a witness protection program shall also submit a statement from the 70 chief executive officer of the agency under whose direction he or she is serving. The petition 71 to close the residential address shall be incorporated into any petition for protective order provided by circuit clerks pursuant to chapter 455. If satisfied that the person filing the 72

petition meets the qualifications of this subsection, the circuit court shall issue an order to the 73 election authority to keep the residential address of the voter a closed record and the address 74 75 may be used only for the purposes of administering elections pursuant to this chapter. The election authority may require the voter who has a closed residential address record to verify 76 77 that his or her residential address has not changed or to file a change of address and to affirm that the reasons contained in the original petition are still accurate prior to receiving a ballot. 78 79 A change of address within an election authority's jurisdiction shall not require that the voter 80 file a new petition. Any voter who no longer qualifies pursuant to this subsection to have his or her residential address as a closed record shall notify the circuit court. Upon such 81 notification, the circuit court shall void the order closing the residential address and so notify 82 83 the election authority.

115.160. 1. All Missouri driver's license applicants shall receive a voter registration
application form as a simultaneous part of the application for a driver's license, renewal of
driver's license, change of address, duplicate request and a nondriver's license.

2. If a single application form is used, the voter registration application portion of any application described in subsection 1 of this section may not require any information that duplicates information required in the driver's license portion of the form, except a second signature or other information required by law.

8 3. After conferring with the secretary of state as the chief state election official responsible for overseeing of the voter registration process, the director of revenue shall adopt 9 rules and regulations pertaining to the format of the voter registration application used by the 10 11 department. The director of revenue shall utilize electronic voter registration application forms and provide for secure electronic transfer of voter registration information to 12 13 election authorities. The secretary of state and the director of revenue shall ensure the 14 confidentiality and integrity of the voter registration data collected, maintained, received, or transmitted under this section. 15

4. No information relating to the failure of an applicant for a driver's license or

Any voter registration application received pursuant to the provisions of this section shall be forwarded, in a secure and electronic manner, to the election authority 20 21 located within that county or any city not within a county, or if there is more than one election 22 authority within the county, then to the election authority located nearest to the location where 23 the driver's license application was received. Voter registration information, including an electronic image of the signature of the applicant, shall be transmitted in a format 24 25 compatible with the Missouri voter registration system established in section 115.158 which allows for review by the election authority and does not require the election 26

27 authority to manually reenter the information, provided that the election authority shall

print out a paper copy of the information and retain such information in the manner required by section 115.145. The election authority receiving the application forms shall review the applications and forward, in a secure and electronic manner, any applications pertaining to a different election authority to that election authority.

6. A completed voter registration application accepted in the driver's licensing process shall be transmitted to the election authority described in subsection 5 of this section not later than [five] three business days after the form is completed by the applicant.

7. Any person registering to vote when applying for or renewing a Missouri driver's license shall submit with the application form a copy of a birth certificate, a Native American tribal document, or other proof of United States citizenship, a valid Missouri driver's license, or other form of personal identification. Any person who, at the time of a transaction with the division of motor vehicle and driver licensing of the department of revenue, provides a document that establishes noncitizenship shall not be offered the opportunity to register to vote as part of the transaction.

115.163. 1. Each election authority shall use the Missouri voter registration system established by section 115.158 to prepare a list of legally registered voters for each precinct. The list shall be arranged alphabetically or by street address as the election authority determines and shall be known as the precinct register. The precinct registers shall be kept by the election authority in a secure place, except when given to election judges for use at an election. Except as provided in subsection 6 of section 115.157, all registration records shall be open to inspection by the public at all reasonable times.

8 2. A new precinct register shall be prepared by the election authority prior to each 9 election.

3. (1) The election authority shall send to each voter, except those who registered by mail and have not voted, a voter identification card no later than ninety days prior to the date of a primary or general election for federal office, unless the voter has received such a card during the preceding six months. The election authority shall send to each voter who registered by mail and has not voted the verification notice required under section 115.155 no later than ninety days prior to the date of a primary or general election for federal office.

16 (2) The voter identification card shall contain the voter's name, address, **political** 17 **party affiliation**, and precinct. The card also shall inform the voter of the personal 18 identification requirement in section 115.427 and may also contain other voting information 19 at the discretion of the election authority.

(3) The voter identification card shall be sent to a voter, except those who registered
by mail and have not voted, after a new registration or a change of address. If any voter,
except those who registered by mail and have not voted, shall lose his or her voter

identification card or change political party affiliation, he or she may request a new [one]
 card from the election authority.

(4) The voter identification card authorized pursuant to this section may be used as acanvass of voters in lieu of the provisions set out in sections 115.179 to 115.193.

(5) Except as provided in subsection 2 of section 115.157, anyone, upon request and payment of a reasonable fee, may obtain a printout, list and/or computer tape of those newly registered voters or voters deleted from the voting rolls, since the last canvass or updating of the rolls.

(6) The election authority may authorize the use of the postal service contractors under the federal National Change of Address program to identify those voters whose address is not correct on the voter registration records. The election authority shall not be required to mail a voter registration card to those voters whose addresses are incorrect. Confirmation notices to such voters required by section 115.193 shall be sent to the corrected address provided by the National Change of Address program.

115.165. 1. If the voter files a change of address application in person at the office of the election authority, at the polling place, or pursuant to section 115.159, 115.160, 115.162 or 115.193, or otherwise provides signed written notice of the move, including notice by facsimile, **electronic**, **or online** transmission, an election authority may change the address on a voter registration record for a voter who moves within the election authority's jurisdiction fatter comparing and verifying the signature. Before changing the address on a voter record, the election authority shall be satisfied that the record is that of the person providing the change of address information.

9 2. A registered voter who has changed his or her residence within an election 10 authority's jurisdiction and has not been removed from the list of registered voters pursuant to 11 this chapter shall be permitted to file a change of address with the election authority or before 12 an election judge at a polling place and vote at a central polling place or at the polling place 13 that serves his or her new address upon written or oral affirmation by the voter of the new 14 address.

3. A registered voter who has changed his or her residence within the state and has not been removed from the list of registered voters under this chapter shall be permitted to file a change of address in person at the office of the election authority on election day. In order to change an address in person on election day under this subsection, a registered voter shall provide a form of personal photo identification required under subsection 1 of section 115.427.

4. If the applicant for registration was last registered in another jurisdiction within this state or another state, the election authority shall send notice of the registration to the election authority where the applicant was previously registered. The election authority

sending the notice shall provide identifying information to assist the election authority receiving the notice to determine whether the person named was previously registered in such jurisdiction and whether, based on the identifying information provided, the application can be removed from the voting record in the former jurisdiction.

[4.] 5. Upon receipt of a notice from another election authority that a voter has 28 registered in another jurisdiction in this state or another state, the election authority shall 29 30 determine whether sufficient information is provided in the notice to identify the person named in such notice as previously registered in the election authority's jurisdiction and 31 32 presently removable from the voting records in the election authority's jurisdiction. Every election authority is authorized to examine the information provided in a notice of duplicate 33 registration provided by the Missouri voter registration system authorized pursuant to section 34 115.158 to determine if a voter in one election authority's voter registration records has 35 subsequently registered in another jurisdiction. If, after reviewing the information provided, 36 the election authority is satisfied that the person identified in the notice is listed as a registered 37 38 voter in the election authority's jurisdiction but has subsequently registered in another 39 jurisdiction, the election authority may remove the person's registration from the list of registered voters. 40

115.168. 1. If a registered voter chooses to change his or her political party 2 affiliation, the voter may notify the election authority of such change. Any change of 3 political party affiliation shall be made by signed, written notice in substantially the 4 same manner as a change of address application is filed under section 115.165.

5 2. For purposes of this section, the phrase "change his or her political party 6 affiliation" shall mean changing affiliation from one established political party to 7 another established political party, changing from affiliation with an established 8 political party to unaffiliated, or changing from unaffiliated to affiliation with an 9 established political party.

115.205. 1. [Any] No person [who is] shall be paid or otherwise compensated for soliciting [more than ten] voter registration applications, other than a governmental entity or a person who is paid or compensated by a governmental entity for such solicitation[, shall be registered with the secretary of state as a voter registration solicitor]. A voter registration solicitor who solicits more than ten voter registration applications shall register for every election cycle that begins on the day after the general election and ends on the day of the general election two years later. A voter registration solicitor shall be at least eighteen years of age and shall be a registered voter in the state of Missouri.

(10) Has been tested and is certified by an independent authority that meets the voting
system standards developed by the Federal Election Commission or its successor agency. The
provisions of this subdivision shall not be required for any system purchased prior to August

3. The secretary of state shall promulgate rules and regulations to allow the use of a computerized voting system. The procedures shall provide for the use of a computerized voting system with the ability to provide a paper audit trail. Notwithstanding any provisions of this chapter to the contrary, such a system may allow for the storage of processed ballot materials in an electronic form.

32 4. Any rule or portion of a rule, as that term is defined in section 536.010, that is 33 created under the authority delegated in this section shall become effective only if it complies with and is subject to all of the provisions of chapter 536 and, if applicable, section 536.028. 34 This section and chapter 536 are nonseverable and if any of the powers vested with the 35 general assembly pursuant to chapter 536 to review, to delay the effective date or to 36 37 disapprove and annul a rule are subsequently held unconstitutional, then the grant of 38 rulemaking authority and any rule proposed or adopted after August 28, 2002, shall be invalid and void. 39

For purposes of this section, an entity specializes in cyber security 57 review if it employs one or more individuals who:

58 (a) Have at least five years management experience in information security or 59 five years experience as an information security analyst;

60 (b) Have worked in at least two of the domains listed in paragraph (c) of this 61 subdivision that are covered in the exam required by such paragraph; and

62 (c) Have attained an information security certification by passing an exam that 63 covers at least three of the following topics:

The secretary of state is also authorized to withhold funds from an election authority in violation of this section unless such funding is a federal mandate or part of a federal and state agreement.

7. The secretary of state shall have authority to require cyber security testing, including penetration testing, of vendor machines, programs, and systems. Failure to participate in such testing shall result in a revocation of vendor certification. Upon notice from another jurisdiction of cyber security failures or certification withholds or revocation, the secretary of state shall have authority to revoke or withhold certification for vendors. The requirements of this section shall be subject to appropriation for the purpose of cyber security testing.

87 8. The secretary of state may designate an organization of which each election 88 authority shall be a member, provided there is no membership fee and the organization 89 provides information to increase cyber security and election integrity efforts.

Each ballot printed or designed for use with an electronic voting system for any election pursuant to this chapter shall contain all questions and the names of all offices and candidates certified or filed pursuant to this chapter and no other. The speaker may obtain legal counsel other than from the attorney general, with the cost of representation paid from funds appropriated for that purpose, to represent the house of representatives in any action in which the speaker intervenes.

7. The president pro tempore of the senate may intervene at any time in an action on behalf of the senate. The president pro tempore may obtain legal counsel other than from the attorney general, with the cost of representation paid from funds appropriated for that purpose, to represent the senate in any action in which the president pro tempore intervenes.

8. The president pro tempore of the senate and the speaker of the house of representatives, acting jointly, may intervene at any time in an action on behalf of the general assembly. The president pro tempore and the speaker, acting jointly, may obtain legal counsel other than from the attorney general, with the cost of representation paid from funds appropriated for that purpose, to represent the general assembly in any action in which the president pro tempore and speaker jointly intervene.

9. No individual member, or group of members, of the senate or of the house of representatives, except the president pro tempore and the speaker as provided under this section, shall intervene in an action described in this section or obtain legal counsel at public expense under this section in the member's or group's capacity as a member or members of the senate or the house of representatives.

10. Notwithstanding any contrary provision of law, the participation of the speaker of the house of representatives or the president pro tempore of the senate in any state or federal action, as a party or otherwise, does not constitute a waiver of the legislative immunity or legislative privilege of any member, officer, or staff of the general assembly.

Section 3. All audits required by subsection 6 of section 115.225 that are 2 conducted by the secretary of state shall be solely paid for by state and federal funding.
